Middle Notes	This is the core of the flavor, dominated by a deep, succulent, true-to-fruit blueberry essence. It delivers a rich, slightly tart complexity to prevent the flavor from becoming overly sugary or artificial. This middle layer is robust enough to carry through the full two minutes of brushing, providing consistent taste and effective masking of the base ingredients.
Base Notes	The residual flavor is a smooth, comforting sweetness with a hint of natural, creamy vanilla or a subtle musky/gourmand undertone. This provides a pleasant, soft finish that leaves the mouth feeling clean and refreshed, without the earthy or woody notes sometimes found in natural fruit. The concentration ensures this pleasant taste lingers after rinsing.

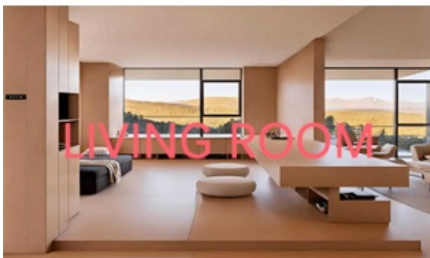

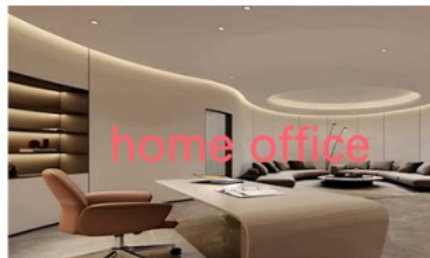
