Top Notes	Bright, Spiced, and Citrusy. The opening features an initial burst of bright citruses (like Bergamot or Lemon) blended with warm spices (such as Cinnamon, Nutmeg, or Cardamom). Some traditional recipes include a unique, creamy-almond scent from Mahlab (a cherry seed spice), giving a subtly sweet and powdery lift.
Heart Notes	Floral, Sweet, and Resinous. Features opulent florals like Rose and Jasmine, contrasting with dark oud. Sweet notes like Dates, Praline, and rich Caramel give the Sudanese fragrance its signature gourmand character.
Base Notes	Deep, Woody, and Animalic. The foundation provides depth and extreme longevity with woody, earthy oud amplified by creamy Sandalwood, warm Vanilla and Tonka Bean, and dark Musk and Amber. This rich, resinous dry-down lasts 8 to 12 hours or more on skin.
