Based on the "Blue" designation—which typically distinguishes this variation from the classic Pink (Sweet/Gourmand) and Orange (Tropical/Mango) Yara scents—this fragrance oil usually follows a Fresh, Aquatic, and Fruity profile. It is often marketed as a "Summer" or "Ocean" version of the Yara DNA, designed to be cleaner and more refreshing for daily wear.

This is an excellent Daily Driver. Because it is fresh and inoffensive, it is perfect for the office, gym, or hot weather when you want to smell polished and clean rather than overly sugary.

Clean, uplifting, and breezy. Unlike the heavy vanilla/creaminess of the original, the Blue version leans into a "cool girl" aesthetic—think fresh laundry drying by the ocean mixed with light fruits.



Fragrance Profile

Top Notes	Opens with a burst of crisp Citrus (likely Tangerine or Bergamot) and sparkling Marine/Ozone notes that give it that immediate "fresh out of the shower" feeling.
Middle Notes	Retains a subtle sweetness with light Tropical Fruits (like Melon or fresh Peach) and soft White Florals, but without the heavy marshmallows or caramel of the other versions.
Base Notes	Settles into a smooth, skin-scent finish of White Musk and light Sandalwood, ensuring it lasts all day without being overpowering.

Technical Functions:

The primary function of this concentrated fragrance oil is to serve as the olfactory core of a finished product, providing the "Fresh/Aquatic" identity that distinguishes the Blue variation from the original Pink (Gourmand) Yara. In a formulation, it acts as a complex mixture of aromatic compounds—including volatile aldehydes for the "ocean breeze" effect and heavier fixatives like Ambroxan for longevity—that interact with the wearer's body heat to release scent over time. Beyond smelling good, the oil functions as a chemical architect, structuring the evaporation curve of the perfume. It ensures that the sparkling citrus top notes lift off the skin immediately, while the hydrophobic musks bind to the skin to extend the

fragrance's life (sillage) for 6–8 hours. In functional perfumery, this oil also serves as a masking agent, effectively covering the harsh chemical odor of ethanol bases or the fatty smell of carrier oils in lotions. Psychologically, its specific "Blue" profile functions to evoke sensations of cooling, cleanliness, and energy, making it a functional mood enhancer for hot weather or high-activity environments.

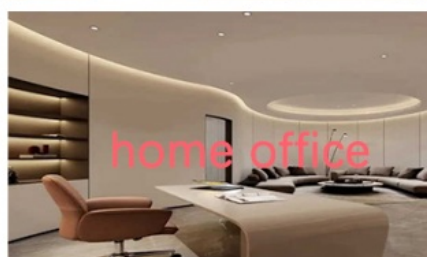
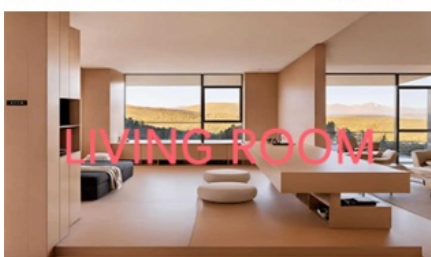
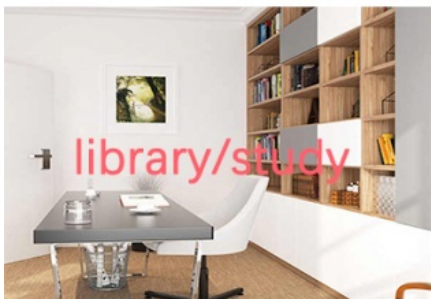


Industry Applications:

This oil is highly versatile and engineered primarily for Ethanol-Based Perfumery. Its most common application is in creating Eau de Parfum (EDP), where it is diluted to 15–20% with perfumer's alcohol. Because of its fresh profile, it is also widely applied in Body Mists and Splashes (diluted to 3–5% with water and solubilizers), which are popular for post-gym refreshes or summer use where a lighter scent cloud is preferred over a heavy perfume.

Beyond sprays, the oil is excellent for Cosmetic Layering. DIY enthusiasts often mix 1–2% of the oil into unscented body lotions, hair oils, or shower gels to create a "matching set" that increases the longevity of the main perfume. It can also be applied directly to pulse points (wrists, behind ears) as a CPO (Concentrated Perfume Oil) or Attar, where it sits close to the skin without projecting aggressively. Finally, its clean, airy nature makes it suitable for Home Fragrance applications, such as ultrasonic diffusers or reed diffusers, to give a room a "fresh laundry" or "ocean air" ambiance without the smoke of candles.
